Notice of Intent

In accordance with the provisions of Section 4-168(a) of the *Connecticut General Statutes* (CGS) the **Office of Early Childhood** hereby gives notice that it proposes to adopt a regulation concerning **licensed family child care homes**.

Comment period (See CGS section 4-168(a)(1)(A))

A comment period of not less than thirty days shall begin upon posting of this notice to the eRegulations System website and shall end on **August 13, 2020**.

Detailed description of the proposed regulation. (See CGS Sec. 4-168(a)(1)(B))

This regulation updates the standards with which licensed family child care homes must comply to require family child care providers to be certified in cardiopulmonary resuscitation, identify specific first aid courses that are acceptable, eliminate the requirement to petition the Office to administer certain medications, provide clarity of existing requirements, comply with recommendations of the National Association for Regulatory Administration (NARA), establish requirements that are consistent with national best practices related to safe sleep practices and emergency preparedness, require carbon monoxide detectors in family child care homes, reduce the restriction of toddlers to children under the age of eighteen months, establish requirements to satisfy the mandates of the reauthorization of the Child Care and Development Block Grant (CCDBG) and make technical revisions.

Statement of the purposes for which the regulation is proposed. (See CGS Sec. 4-168(a)(1)(C))

The purpose of this regulation is to amend the regulations governing family child care homes to require family child care providers to be certified in cardiopulmonary resuscitation, identify specific first aid courses that are acceptable, eliminate the requirement to petition the Office to administer certain medications, provide clarity of existing requirements, comply with recommendations of the National Association for Regulatory Administration (NARA), establish requirements that are consistent with national best practices related to safe sleep practices and emergency preparedness, require carbon monoxide detectors in family child care homes, reduce the restriction of toddlers to children under the age of eighteen months, establish requirements to satisfy the mandates of the reauthorization of the Child Care and Development Block Grant (CCDBG) and make technical revisions.
