The contract between **Triple P America**, Inc. (the Contractor) and Department of Social Services (the Department), which was last executed by the parties and signed by the Commissioner on 1/24/13, is hereby amended as follows:

- The Originating Agency is changed from the Department of Social Services to the Office of Early Childhood
  pursuant to Executive Order #35 of Governor Dannel P. Malloy promulgated 6/24/13 and Public Act 14-39.
  All references to "Department of Social Services" are deleted and replaced with "Office of Early Childhood," and
  all references to "Children's Trust Fund" are deleted and replaced with "Family Support Services Division."
- 2. The total maximum amount payable under this contract is **increased by \$50,000 from \$330,000 to \$380,000** to fund services as originally contracted through 6/30/16.
- 3. The term of the contract is increased by one additional year and the end date of the contract is changed from 6/30/15 to 6/30/16.
- 4. The following subsection shall be appended to the Triple P Training section in Part I, Section D.3 on page 4 of the original contract:
  - h. The Contractor will provide one 3-day Level 4, Standard Triple P training and one pre-accreditation workshop to a maximum of 20 participants at a cost of \$31,780 composed of \$28,255 for the Standard Triple P Training and \$3,525 for the Pre-accreditation Workshop.. In addition, the Contractor will provide parent workbooks, tip sheets, videos and any other Triple P materials at a cost of \$18,220.
- 5. The Department's Fiscal contact person in Part, Section H.1.b on page 7 of the original agreement is changed to Pietro Rosato, Director, Business Operations, State of Connecticut Office of Early Childhood, 165 Capitol Avenue, Hartford, CT 06106; pietro.rosato@ct.gov (860) 713-6418.

This document constitutes an amendment to the above numbered contract. All provisions of that contract, except those explicitly changed above by this amendment, shall remain in full force and effect.
